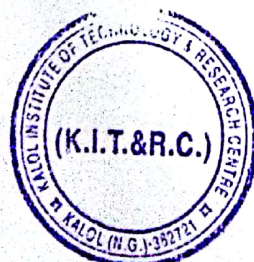


Committee shall also constitute a smaller body to be known as the Anti Ragging Squad for maintaining vigil, oversight and patrolling functions and shall remain mobile, alert and active at all the times. Anti Ragging Squad shall have representation of various members of the campus community and shall have no outside representation. It shall be the duty of the Anti Ragging Squad to be called upon to make raids on hostels and other places.

It shall be the duty of the Anti Ragging Committee to insure compliance with the provision of the regulations as well as the provision of any law for the time being in force. Concerning ragging and also to monitor and oversee the performance of the Anti Ragging Squad in prevention of ragging in the institute and institute hostel.
